

2018 Registered Family Child Care (FCC) Family, Friend, and Neighbor (FFN)/Approved Home/In-Home Mandatory Orientation Schedule

Orientation is now a mandatory process for prospective providers that plan on becoming State Registered (along with their substitute, assistant, and alternate) and FFN/Approved Home providers.

During this three-hour orientation, you will review the *Manual of Requirements for Family Child Care* and start completing the paperwork required for either Family Child Care or FFN/Approved Home/In-home providers. You will receive credit for three hours of training. During the last 30 minutes, we will assist prospective providers in getting signed up with the NJ Workforce Registry (formerly PINJ), which is required to attend training and complete the process of becoming a provider. It will be necessary to sign up for the required Health & Safety, Child Development, and Child Abuse & Neglect Training through NJ Workforce Registry (formerly PINJ) to continue on in the provider process.
