#### **Universal School Mask Mandate**

On February 7, 2022, Governor Murphy announced that the state-wide Mask Mandate would lift on Monday, March 7, 2022.

Child care centers and providers can continue to implement the usage of face-covering within their facilities.

Providers must submit the *Provider Report of Child Care Terminations Form* to CCC when a family disenrolls, indicating the last day of care.

#### **Payment On Enrollment versus Attendance**

On December 22, 2021, the Division of Family Development (DFD) announced that child care subsidy payment based on enrollment extends through June 30, 2022.

Providers will continue to receive payment for all days of *authorized* child care agreements for enrolled students through June 30, 2022.

Providers are required to keep their own attendance records.

Further details will be sent as instructions become available from DFD.

#### CHILD CARE COVID FAMILY DIFFERENTIAL PAYMENTS

DFD announced *The Family Differential Payment* extension for licensed child care providers and family child care providers (FCC). The Family Differential Payment <u>replaces</u> the previous *Supplemental Payment* program. The differential payments help pay the tuition difference and reduce other costs or fees that families pay, e.g., payments that are not covered by child care reimbursement payments. If a provider's rate is greater than the New Jersey child care reimbursement rate, the provider must reduce the family's cost of care by applying the additional amount received through the Family Differential Payment.

The monthly equivalent of \$300 (\$13.86/per day) for full-time care and \$150 (\$6.93/per day) for part-time care has been added to the regular, daily subsidy child care rate in your web portal. Payment continues to occur through direct deposit in the ECC system.

This directive is extended and remains in effect from January 1, 2022, through December 31, 2023.

Please review the agreement details for each child by reviewing your provider web portal.

\*\*\*The Family Differential Payments extension **does not** apply to Approved Homes. They will no longer receive the differential payments.\*\*\*
